

**EAST SIDE HIGHWAY DISTRICT
ORDINANCE NO. 2009-001**

AN ORDINANCE OF EAST SIDE HIGHWAY DISTRICT ESTABLISHING REGULATIONS FOR USE OF BOOTHE PARK IN ORDER TO PROMOTE AND PROTECT THE HEALTH, SAFETY AND GENERAL WELFARE OF CITIZENS OF THE COUNTY

WHEREAS, the Board of Commissioners of East Side Highway District is the duly elected governing body of East Side Highway District, a political subdivision of the State of Idaho, having such powers and duties as are set forth in the Statutes of the State of Idaho

WHEREAS, Boothe Park is a public park dedicated to East Side Highway District for the use and enjoyment of the public;

WHEREAS, East Side Highway District Board of Commissioners desire to inform residents and park users, boaters and swimmers at Boothe Park by providing clearly articulated regulations, thus enabling a more compatible recreational experience; and

WHEREAS, the Board of Commissioners have determined that regulation of parking and hours of use enhances the use and enjoyment of the public and serves to protect the improvements in Boothe Park;

NOW THEREFORE BE IT RESOLVED, by the Board of Commissioners of East Side Highway District that:

1. The general purpose of the Ordinance is to promote and protect the health, safety and general welfare and the quality of life of the public, and to protect public and private property and the quality of Boothe Park.
2. The provisions of this Ordinance are enacted pursuant to the general authority granted to the Board of Commissioners by Idaho Code, Section 40-1310.
3. The hours that Boothe Park is open for public use shall be 5:00 a.m. to 10:00 p.m.
4. No parking of vehicles in the parking area shall be allowed overnight.
5. In addition to any and all remedies available at law or in equity, each violation of the provision of this ordinance shall be a misdemeanor punishable by a fine of not more than three hundred dollars (\$300.00) or by imprisonment not to exceed six (6) months, or by both such fine and imprisonment.
6. This ordinance shall take effect and be in full force and effect upon publication of a public notice in a newspaper of general circulation in Kootenai County, as prescribed by law.
